19. The price premium for incumbents’ services is less pronounced when voice services are also included
20. The price premium for the incumbent’s triple-play package is frequently 15–40%, despite a weaker choice of programming

22. Fixed broadband promotions tend to have the features of one or more of the four basic types
23. The most-popular pricing promotions are those that reduce barriers to entry
24. The top-ten promotions in terms of cost savings offer price reductions of 20–50%

26. The price premium for ultra-fast broadband has stabilised at 24% despite a decline in absolute median prices
27. The price premium for voice and TV services varies significantly between markets

29. Mobile broadband pricing undercuts comparable entry-level fixed broadband packages now in most of Western Europe

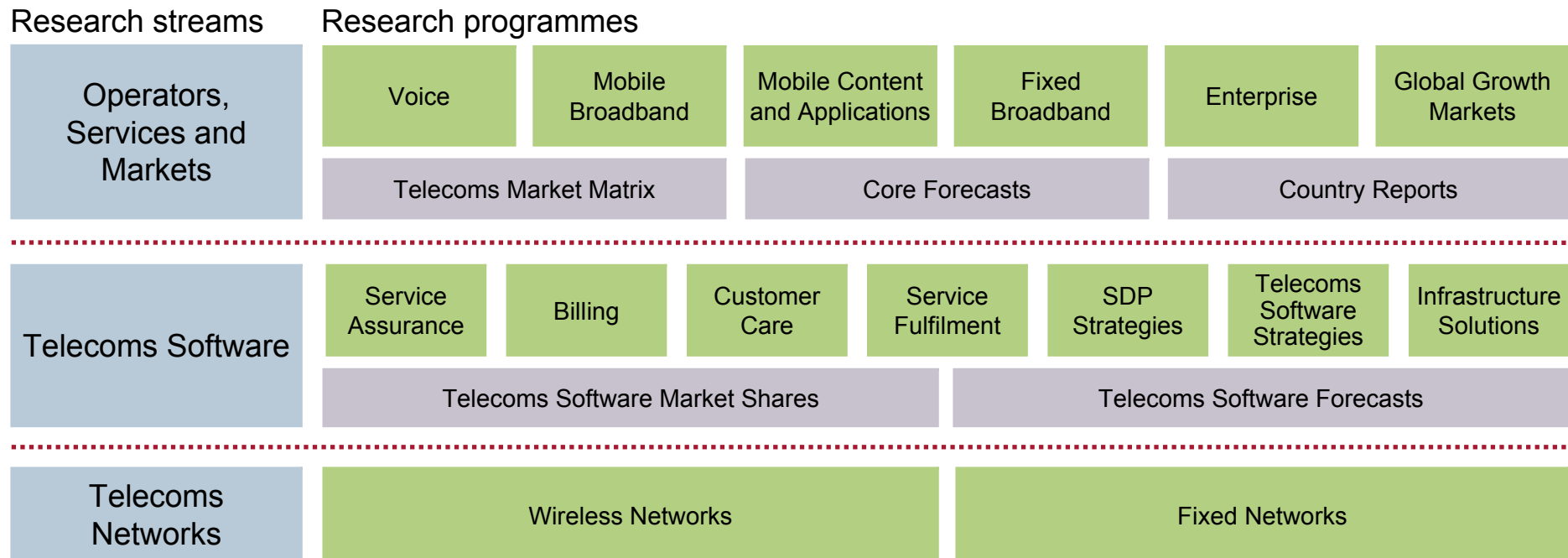

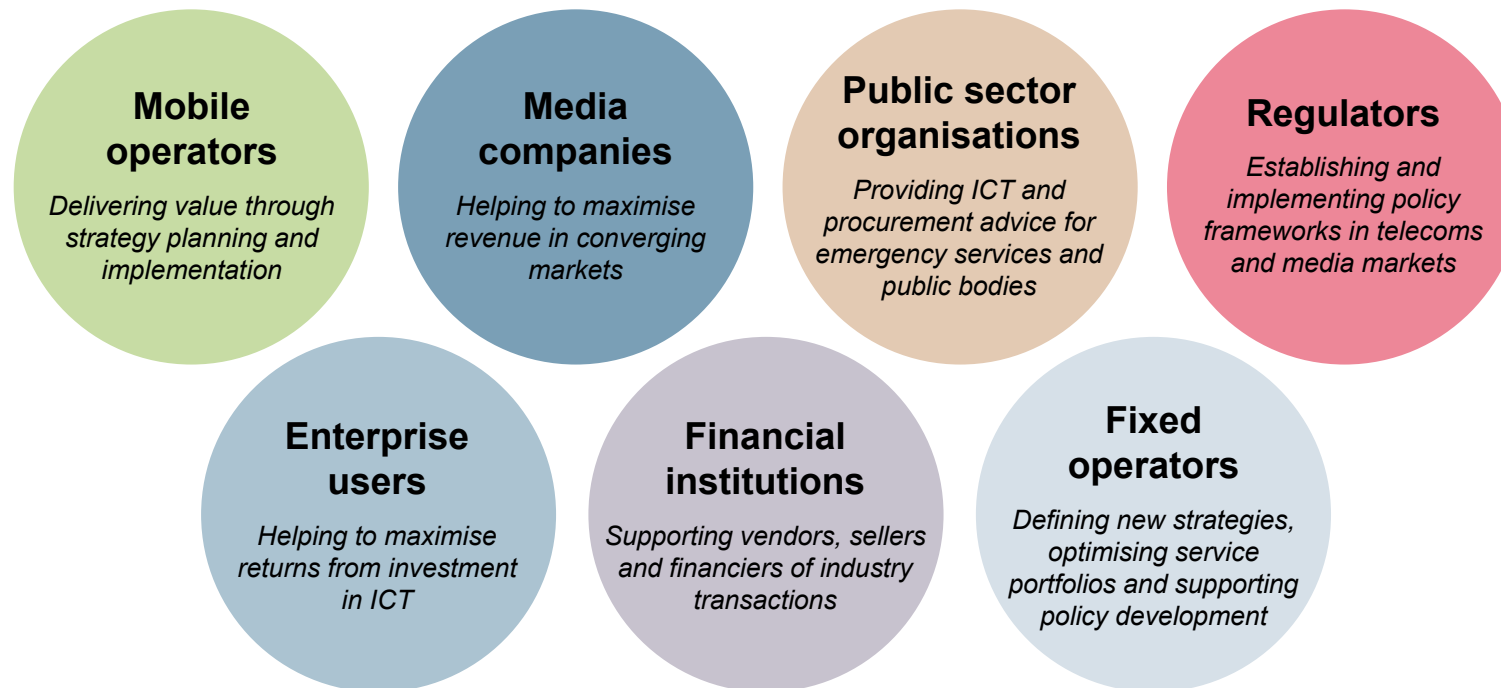
