- 5G will be a major tool for stimulating demand across verticals. Not only Backhaul and Trunking will benefit from higher bandwidth requirements and coverage expectations, but easier integration with Telco, Cloud and Edge will unlock new opportunities in the Corporate Networks segment. The requirements of Mobility segments match very well with the network flexibility brought by 5G, creating extraordinary opportunities for Maritime, Aero, Land Mobile or even Gov/Mil verticals.
- The pace of innovation in the satellite industry is accelerating. The satellite industry must avoid re-inventing the wheel and can leverage many of the tools developed in the 5G ecosystem to reach scale, reduce time to market and enhance performances. Cloud, virtualization and standardized service orchestration will play a fundamental role in the coming years, also transforming the Business Models across the value chain.
